We have received your letter of 1st March 1995 enquiring about the receipt of the foreign contribution of \$20,000 which was granted to us by the Institute of International Education, New York.

We were granted permanent registration under the FCRA. Our registration number being 010230292. In accordance with the requirements of FCRA we had submitted FC 3 forms for 1992-93 and 1993-94 on 2.6.1994. I would like to bring to your notice that a part of the amount Rs. 2,03,190 (\$6500) from Institute of International Education which was received in the year 1993-94 was mentioned in the FC 3 form for the said period which was sent to you on 2.6.1994 by speed post.
