



Subject: Non-submission of application for renewal of registration Certificate under FCRA-2010.

As per Section 16 of Foreign Contribution (Regulation) Act, 2010 (FCRA 2010) and Rule 12 (2) of Foreign Contribution (Regulation) Rules 2011 (FCRR 2011), associations registered under FCRA 2010 are required to renew their registration by applying to the Central Government in Form FC-3, six months before the date of expiry of the certificate of registration under section 12(2) of FCRA Rules, 2011. In order to facilitate the Associations to apply for renewal in new FCRA system date of application was relaxed and extended upto 30/06/2016.

2. On scrutiny of records, it has been found that online application of your association for renewal has not been received in this Ministry despite time relaxation and extension given.

3. Hence, you are called upon to show cause within one month of the issue of this letter as to why FCRA registration of your association should not be cancelled.
